- **Requests for waivers/exceptions:** Any requests for waivers/exceptions <u>must be brought to the</u> <u>Board for a decision.</u>
- **Cleaning Fee:** The Cleaning Fee will be the actual/full fee the SPVCA pays its cleaning provider, based on the rate in effect at the time the Facility Use Agreement is signed. \$180 is the rate as of August 2023.
